Dear Applicant:

This is in response to your August 31, 2016 request to be exempt from the requirement to file Form 990, Return of Organization Exempt from Income Tax.

Treasury regulation section 1.6033-2(g)(1)(ii) provides that an exclusively religious activity of any religious order exempt from taxation under Internal Revenue Code (IRC) Section 501(a) isn't required to file Form 990, Return of Organization Exempt From Income Tax.

Based on the information you provided, we determined you are a religious order that conducts exclusively religious activities. Therefore, in accordance with the above regulation, you are not required to file Form 990. We will update our records accordingly.

This is a determination that your exclusively religious activity doesn't need to be reported on an annual return or notice required by IRC Section 6033. This is not a ruling under Revenue Procedure 91-20, 1991-10 I.R. B. 26, that you're a religious order for purposes of self-employment tax, the Federal Insurance Contributions Act (FICA) tax, and federal income tax withholding, respectively. To request such a ruling, see Revenue Procedure 2016-1 or its successor.

As an organization exempt from federal income tax under section 501(c)(3), you must fulfill a number of other requirements under the Internal Revenue Code. For important information about your responsibilities as a tax-exempt organization, go to www.irs.gov/charities. Enter "4221-PC" in the search bar to view Publication 4221-PC, *Compliance Guide for 501(c)(3) Public Charities*, which describes your recordkeeping, reporting, and disclosure requirements.
